The United Nations University (UNU) is searching for an entrepreneurial director for the re-launch of its computing and information technology institute in Macao, SAR, China. The new institute will be called UNU Computing and Society.

A focused research programme, to be developed in collaboration with the Board of the Institute, should contribute, through impact and policy advice, to the goals and priorities of the emerging UN development agenda. The Institute's scope for doctoral and postdoctoral fellowships should contribute to nurturing the next generation of computing and information scientists and engineers in developing countries.

#### **Responsibilities:**

The Director reports to the Rector of the United Nations University, and works closely with the Board of the Institute Board. This Director will set the vision and build an ambitious, cutting-edge, multidisciplinary research programme to address key challenges faced by developing societies through high-impact innovations in computing and information technologies. We are looking for a dynamic individual with a strong academic and management background who can recruit and lead a world-class team of researchers, and build partnerships with universities, think tanks and the private sector.

The Institute enjoys stable base funding derived from its endowment and significant additional support from Macao.

#### **Required Qualifications and Experience:**

The successful candidate should have:

- A PhD in a relevant discipline
- A strong background of research in an area of particular relevance to developing societies such as health, education, agriculture, disaster management, livelihoods, etc.
- A reputation for visionary leadership in an academic or research institution
- The ability to build up an exciting new institute and to recruit and lead a dynamic team of worldclass researchers
- Demonstrated capacities in building and sustaining international networks and partnerships
- Strong fundraising skills and experience
- Excellent management and communications skills favouring work with colleagues of diverse cultural and disciplinary backgrounds
- A deep commitment to issues of human development

Applications from suitably qualified female candidates are particularly encouraged.

#### Remuneration:

Approximate net salary (free of tax) of US\$ 131,375 (single status) – US\$ 149,600 p.a (with dependants) including post adjustment. Post adjustment is subject to change.

The post carries the standard set of UN entitlements/benefits, including participation in the United Nations Joint Staff Pension Fund, the possibility of participation in a health insurance programme, education grant for eligible children, removal expenses and home leave.

#### **Duration of Contract:**

The period of initial contract would be for a four-year term with the possibility of renewal for a further four years on the basis of excellent performance. The mandatory retirement age in the United Nations is 65 years.
