I. PRESENTATION

• The Operational Unit of UNU-INRA in Côte d'Ivoire was set up in 2004 in CIRES (Ivorian Centre for Economic and Social Research). It is focused on the socio-economic aspects of the use, the management and the exploitation of natural resources in connection with the biotechnology, food security and poverty mitigation.

• The O.U CI was formerly managed by Dr. Barry who passed away last year (June 2010). Since November 2011, the O.U is managed by a new team of four (4) researchers.

III. PROGRAMMES

<u>Programme I</u>: Elaboration of the directory of national NGOs working in the field of sustainable management of the environment and natural resources

This project aims at trying to list all NGOs which get involved in the field of the management of natural resources and environment in CI. It is going to allow us to review what is done? Who does what and how it is done. It will create a synergy of actions between the various actors and guide us in our subjects of research for efficiency in the management of natural resources. It's implementing by financial support of CIRES.

III. PROGRAMMES (be continued)

<u>Programme II</u>: Impacts of socio-political crisis on natural

resources, food security and poverty

One of the direct consequences of the crisis in CI is the massive migration of population toward the protected zones. The general objective of this study is to measure the impact of the crisis on natural resources in protected areas.

More specifically the project aims at:

 \checkmark (1) studying the production systems of displaced farmers living inside the protected area;

 \checkmark (2) identifying potential sources of conflict between host populations and migrants, on the use of arable land, forest resources and water;

 \checkmark (3) measuring also the impact of migrations on food security and poverty.
