United Nations University Maastricht Economic and social Research Institute on Innovation and Technology (UNU-MERIT)

UNU-MERIT is a research and training institute of the United Nations University (UNU) and Maastricht University (UM), based in southeast Netherlands. The institute, which collaborates closely with <u>Maastricht University</u>, carries out research and training on a range of social, political and economic factors that drive economic development in a global perspective. Special emphasis is on the process of technological change and innovation, including the governance of science and technology and on factors limiting the access to knowledge; on (public) policy analysis and evaluation; on the social aspects of growth and development, in particular the policy challenges posed by low levels of development including the limitations and possibilities for social security and other social policies; and on the relationship between global development and migration.

The Maastricht Graduate School of Governance (MGSoG) of Maastricht University is integrated within UNU-MERIT; MGSoG is the centre for UNU-MERIT's double degree Master of Science in Public Policy and Human Development, which aims to train public policy professionals for the global community. UNU-MERIT, including MGSoG, has been closely involved in research for a variety of UN agencies, including the International Labour Organization (ILO), the United Nations Children's Fund (UNICEF), the United Nations Industrial Development Organization (UNIDO), and the World Bank.

Overall the institute functions as a unique research centre and graduate school for around 100 PhD fellows and 140 Master's students. It is also a UN think tank addressing a broad range of policy questions on science, innovation and democratic governance. Responsibilities

Under the authority of the Director and the supervision of the Head of Communications at UNU-MERIT, the successful candidate will carry out the following tasks:

- Support the planning and organisation of communications-related work at UNU-MERIT, including the MGSoG: i.e. media relations, online communications, social media, publications, multimedia productions, and targeted communications for stakeholders such as funders, scholars and journalists;
- Act as junior editor for all major publications and the Institute's website with a view to communicating the results of academic research to the academic community, policymakers, the media and general public;
- Work as part of a team to prepare documentation required by the UNU Council, contribute to strategies for outreach activities, write press releases and manage the production and graphic processes involved in the preparation of documents for publication, both in electronic and hard copy format;
- Act as junior public relations officer for the Institute, including at both local and international events.

Required Qualifications and Competencies

The successful candidate will:

- have fluency in English and at least one other official language of the United Nations;
- have a Master's degree in communications, international relations or other field relevant to the overall work of the United Nations University;
- have worked for at least five (5) years in journalism and/or communications at international level;
- have worked for at least three (3) years on media campaigns for international organisations, with direct experience of media monitoring, evaluation and promotion;
- have previously worked in a communications capacity for a major international organisation;
- have previously worked on core United Nations themes such as climate change, sustainable development and human rights;
- have demonstrated experience in producing and promoting multimedia including podcasts, webcasts, video clips, etc.;
- have a proven track record of growing the social media profiles of international organisations;
- have experience of public speaking in international fora;
- have strong interpersonal skills demonstrated by the ability to work in a multicultural, multi-ethnic environment with sensitivity and respect for diversity;
- be a confident, pro-active and innovative team player.

Desirable Experience and Competencies

The successful candidate will ideally:

- have English as his/her first language;
- have previously worked as a journalist;
- have prior experience of editing academic journals;
- have a proven track record in conference management at international level;
- ➤ have previous experience in the field of science, technology and innovation.

Remuneration

Remuneration will be commensurate with qualifications, experience and level of responsibilities.

Duration of Contract:

This is a full-time employment on a one (1) year Personnel Service Agreement (PSA) contract with UNU, with the possibility for renewal subject to requirements and satisfactory work performance, and the combined duration of appointments not exceeding six (6) years.

This is a locally recruited post and no relocation allowances apply. The successful candidate will be employed under a local contract and will not hold international civil servant status nor is he/she a "staff member" as defined in the UN Staff Rules and Regulations.
