

Much of the debate on green growth and environmental governance tends to be general in nature, and is often conceptual or limited to single disciplines. Even though recent discussions on these topics have benefited from the accumulation of empirical and theoretical knowledge over the last few decades, these discussions have not produced the kind of conceptual novelty and tools necessary to place the notion of a green economy within mainstream political, social and economic agendas. Furthermore, discussions on governance remain mostly in the international sphere with merely tenuous talk on governance at the national and subnational levels – the levels at which implementation is key. The contributors to this book present the gap that can emerge between intentions and results when green initiatives are put into practice, and highlight the lack of discussion on important topics such as equity.

Green Economy and Good Governance for Sustainable Development takes stock of the achievements and obstacles towards sustainability over the last 20 years, and proposes new ideas and changes to create a more sustainable future.



Norms of Protection

Responsibility to Protect, Protection of Civilians and Their Interaction

EDITED BY ANGUS FRANCIS, VESSELIN POPOVSKI AND CHARLES SAMPFORD

A series of humanitarian tragedies in the 1990s (Somalia, 1992-1994; Rwanda, 1994; Srebrenica, 1995; Kosovo, 1999) demonstrated the failure of the international community to protect civilians in the context of complex emergencies. These brought to life two norms of protection - Responsibility to Protect (R2P) and Protection of Civilians (POC) both deeply rooted in the empathy that human beings have for the suffering of innocent people. The norms have achieved high-level endorsement: R2P from the 2005 World Summit Outcome document (Art. 138–140) and POC from a series of Security Council resolutions. The two norms of protection were instrumental in adopting Security Council Resolutions 1970 and 1973 (Libya), and 1975 (Côte d'Ivoire) in 2011. Both norms raise concerns of misinterpretation and misuse. They are developing - sometimes in parallel, sometimes diverging and sometimes converging - with varying degrees of institutionalization and acceptance. This process is likely to continue for some time with successes and failures enhancing or retarding that development. This book engages in a profound comparative analysis of the norms and aims to serve policymakers at various levels (national, regional and UN); practitioners with protective roles (force commanders, military trainers, strategists and humanitarian actors); academics and researchers (in international relations, law, political theory and ethics); civil society and R2P and POC advocates.

Angus Francis is Senior Lecturer and Program Leader, Human Rights and Governance Program in the Faculty of Law at Queensland University of Technology, Australia. Vesselin Popovski is Senior Academic Programme Officer and Head of Peace and Security at the United Nations University Institute for Sustainability and Peace, Japan. Charles Sampford is Foundation Dean, Professor of Law and Research and Professor of Ethics at Griffith University, and Director at the Institute for Ethics, Governance and Law, Australia.



Ethics and International Affairs explores the extent and limits of contemporary international ethics and examines the ways in which the international community has responded to some of the most crucial challenges since the end of the Cold War.

At the centre of the book is a discussion of how responsibility is viewed at individual, national and international levels when facing the problems of human rights, humanitarian intervention, environmental issues, considerations of gender, international economic justice, matters of war and peace and the plight of refugees. While some authors revisit the conception and interpretation of international ethics, others focus on the necessity to push for the better implementation and improvement of existing international norms.

The result is an examination of how ethics are defined in today's specific contexts and how an understanding of the ethical may be developed from the articulation of the dilemmas encountered.

The issues tackled in the book were already topical ten years ago, at the time of the first edition. In 2013, the year of publication for this second edition, following the tumultuous decade of the early 2000s, they have only gained in importance.



International Rule of Law and Professional Ethics

EDITED BY VESSELIN POPOVSKI

The concept "rule of law" is well established in domestic constitutions and over many centuries has evolved to signify the supremacy of law above the rich and the powerful, above the potential arbitrariness or bias of human decisions.

This book investigates the concept "international rule of law", which can be a problematic one as terms such as "international democracy", "international welfare" or "international freedom of speech" are not commonly used. International rule of law is defined as a process of recognition worldwide that law, both domestic and international, must be supreme and must remain detached from both power and bias. The authors argue that international rule of law is a gradual ascendance of law above power internationally, which can be illustrated in two ways: by global acceptance of the principles of rule of law and by repeated rulings of international tribunals, reaffirming that the supremacy of law places it above political, economic or other considerations. The book also examines how professional ethics, in particular the ethical behaviour of various groups of international employees, such as judges and prosecutors in international tribunals, diplomats and legal advisors, international civil servants and commissioners, can contribute to the development of the international rule of law.



The Role of Ecosystems in Disaster Risk Reduction


The increasing worldwide trend in disasters, which will be aggravated by global environmental change (including climate change), urges us to implement new approaches to hazard mitigation, as well as exposure and vulnerability reduction. We are, however, faced with hard choices about hazard mitigation: should we continue to build dikes and walls to protect ourselves against floods and coastal hazards - though we have seen the limits of these – or should we consider alternative, ecosystem-based solutions? Ecosystem management is a well-tested solution to sustainable development that is being revisited because of its inherent "win-win" and "no-regrets" appeal to address rising disaster and climate change issues. It is one of the few approaches that can impact all elements of the disaster risk equation – mitigating hazards, reducing exposure, reducing vulnerabilities and increasing the resilience of exposed communities. Yet, the uptake of ecosystem-based approaches for disaster risk reduction (DRR) is slow despite some very good examples of success stories. Reasons for this are multiple: ecosystem management is rarely considered as part of the portfolio of DRR solutions because the environmental and disaster management communities typically work independently from each other; its contribution to DRR is highly undervalued compared to engineered solutions and thus not attributed appropriate budget allocations; finally, there are poor science-policy interactions on ecosystem-based DRR, which have led to unclear and sometimes contradictory scientific information on the role of ecosystems in DRR.

The aim of this book is to provide an overview of knowledge and practice in the multidisciplinary field of ecosystem management and DRR to encourage and further develop dialogues between scientists, practitioners, policymakers and development planners.

"Climate change adaptation", "building resilience" and "vulnerability and risk reduction" are noble words, but do we really know what is meant by these terms and how to assess their respective progress? *Measuring Vulnerability to Natural Hazards* seeks to address these questions.

The world has recently experienced disasters of a magnitude rarely seen before: the cascading disaster in Japan, the earthquake in Haiti, and floods in Pakistan and Australia are a few prominent examples. These major disasters underline the fact that many communities and world regions are still vulnerable to extreme events and natural hazards. The dynamic and complex interaction between vulnerable communities, and climate- and non-climate-related, sudden-onset and creeping hazards very probably increases the risk of crises and disasters in the future.

Measuring Vulnerability to Natural Hazards is a completely revised, second edition of the popular book of the same title. Aside from being fully updated, this new edition includes the dimension of adaptation to climate change and new risks resulting from climate change. The text provides and combines practical examples from Africa, Asia, the Americas and Europe with theoretical and conceptual frameworks. It is key reading for all those interested in improving risk reduction and adaptation strategies to extreme events and gradual changes in the context of climate change and natural hazards. Measuring vulnerability and evaluating adaptation are essential prerequisites to strengthen the capacities of communities in building resilience through knowledge-based approaches.

The decline of authoritarianism in Latin America and Eastern Europe marked the end of a dark chapter in the history of these societies. In both regions, transition to democracy was accompanied by distinct efforts to come to terms with the traumatic experiences of the past and to demand accountability from the oppressors. 

Exorcising the Demons Within

On 11 May 2008, residents of Alexandra Township near Johannesburg turned violently on their neighbours, launching a string of attacks that, two weeks later, left 60 dead, dozens raped and over a hundred thousand displaced. Most of those killed were from beyond South Africa's borders, but at least a third were citizens who, for reasons of ethnicity or political affiliation, failed to protect their space in the country's urban core. Although not the most severe political violence in South Africa's turbulent past, the 2008 attacks reflect an important moment in the country's post-apartheid, post-authoritarian existence: a moment when the government's legitimacy and the post-apartheid order were called into question. This xenophobic violence made evident cracks in the cohesion of law and society while helping to redefine both.



In the aftermath of violent conflict, no society can afford to rebuild its future without the participation of its young generation and consideration for their interests and needs. Yet, trapped in a state of protracted victimhood, children and youth – and their needs and potential – risk being overlooked in the planning and implementation of post-conflict peacebuilding. Their voices will not be heard unless they can escape the chains of victimhood and their agency in post-war recovery effort is recognized.



Friend or Foe? Dominant Party Systems in Southern Africa

Within southern Africa, there is an observable increase in dominant party systems, in which one political party dominates over a prolonged period of time, within a democratic system with regular elections. This party system has replaced the one-party system that dominated Africa's political landscape after the first wave of liberations in the 1950s and 1960s.
